3. PROCEDURES, ELIGIBILITY, SELECTION

- There shall be a maximum of **Twelve (12) runners** of which eight (8) spots will be reserved for Barbados based horses.
- Barbados based horses means:-
 - **horses which ordinarily race in Barbados or are intended to be based in Barbados for racing, or**
 - **horses owned by persons who ordinarily or habitually reside in Barbados (or who have raced horses in Barbados on a regular basis over the past two years)**
- In the event that nominations for more than **twelve (12) horses** are received, the Barbados Turf Club reserves the right to establish its own criteria for the selection of the ranking of the horses.
- The Classification Committee will announce and publish the rankings not later than **Monday 8 February, 2009.**

4. DECLARATION

Declaration for the race shall be on or before **Thursday 4 March, 2010 at 10:00AM.**, and any vacancies in the race will be filled by horses in the order of preference of the rankings published by the Classification Committee.
